In accordance with the authority conferred by Ohio law, you have been placed on probation by the Court. Your period of probation will continue until terminated by this Court. Your term of probation may last until you are 21 years of age. The Court may revoke your probation for cause, or if necessary, modify the conditions of your probation. The Court may issue an arrest warrant if you have allegedly violated your probation. You are also subject to arrest by any Probation Officer without a warrant for violation of the terms of probation. Both you and your property including, but not limited to all electronics are also subject to search and confiscation by any Probation Officer without a warrant. The terms of your probation are subject to the continuing jurisdiction of the Court. It is the Order of the Court that you comply with the following conditions of probation:

Probationer's Responsibilities

- 1. The probationer will not violate any city ordinance, state or federal law. The probationer will notify the Probation Officer of any law enforcement contact within 24 hours. The probationer will follow all lawful rules set forth by parents, school, placement and Probation Officer.
- 2. The probationer will comply with all Court Orders and complete all programming (anger management, substance abuse, etc.) directed by the Probation Officer in accordance with the Probation Case Plan. The probationer will be honest and involved with any and all services/assessments requested.
- 3. The probationer will follow a curfew set forth by Juvenile Court and parents. Your curfew is daily. The exception to this curfew is if the probationer is under the direct supervision and accompaniment of a parent or if permission has been granted, in advance, by the Probation Officer.
- 4. The probationer will not be truant from home, school, or placement.
- 5. The probationer will not leave the State of Ohio for more than 24 consecutive hours without the prior approval of the Probation Officer. Further the probationer will report any change of address and phone number within 72 hours.
- 6. The probationer will not carry or have in his/her possession alcohol, illegal drugs, prescription medication (not prescribed), or synthetic drugs.
- 7. The probationer will not test positive for any illegal drugs or alcohol. The probationer will be required to submit to random drug testing. Failure to provide a sample may be viewed as a refusal.
- 8. The probationer will not carry or have in his/her possession a firearm, ammunition, or weapons of any kind. In the event a probationer would like to go hunting, the probationer will have to obtain permission at least 24 hours in advance from the Probation Officer.

- 9. The probationer will provide all username and password information for all electronic devices along with social media applications to the Probation Officer upon request.
- 10. The probationer will attend all meetings scheduled by the Probation Officer.
